- 2) A valid state issued driver's license or other official government issued photo identification, i.e., passport.

\*Your dental or healthcare provider will verify your applications for completeness and accuracy and submit it for credit approval. If you have any questions, please contact your dental or healthcare provider where treatment is to be performed. Compassionate Healthcare Services cannot process your application for approval except through direct submission from member practices.

All information submitted to us shall remain your property. **COLLECTED INFORMATION:** We automatically collect information knowingly provided by you in the application process such as your name, street address, e-mail address, telephone number (home, work and mobile), date of birth, Social Security Number, bank account information and other personal, financial or demographic information. Please understand that the information that you submit to us is voluntary, but required if you request a credit from us.
